- Service Truck Crane Operator Only—must have a minimum of 500 hours of crane-related experience on any crane type (e.g., Service Truck, Mobile)
- Digger Derrick Operator—must have a minimum of 500 hours of actual operating experience on digger derricks.
 - Dedicated Pile Driver Operator—must have a minimum of 500 hours of actual operating experience on dedicated pile drivers.
